Industry Overview

By 2024, the total individual wealth in India is estimated to cross INR 800 Lac Cr from the 2019 level of INR 430 Lac Cr in 2019, growing at a CAGR of 13.19%.

The allocation to Financial Assets is estimated to double to INR 530 Lac Cr in 2024 from INR 260 Lac Cr in 2019.

Over 2019-2024 the total no. of HNIs is expected to cross 500,000 (CAGR of 73%). During the same period, the no. of UHNIs will cross 10,000.


